CEFAS specialises in efficacy and safety trials providing evidence for product regulatory approval. A range of *in vitro* and *in vivo* test models have been developed and validated, these are available for testing all types of products. We have the staff, facilities and quality assurance systems (including GLP and ISO 17025) to provide experimental evidence of the highest scientific quality. This includes the authorisation of new products, changed formulations or reauthorisation.

laboratory testing range Our product safety and efficacy testing services are available for a range of products intended for the aquaculture market including disinfectants, feed additives, probiotics, prebiotics, immunostimulants, vaccines, fungicides, antiparasitics, antibiotics and other pharmaceuticals. Our tests follow detailed protocols and procedures, complying with the requirements of relevant regulatory texts and providing high quality data for registration packages. Where protocols are not specified, we can advise on their design.

Examples of our specific tests include disinfectant testing to specified standards, finished product batch testing, target safety, residue depletion and radio-labelled metabolism studies, and efficacy testing against diseases from around the world.

facilities Our modern GLP compliant aquarium facilities provide excellent flexibility to accommodate all trial requirements. We have over 200 computer controlled tanks in 14 isolation suites suitable for a wide variety of marine and freshwater fish species.

As a National Reference Laboratory we are uniquely placed to ensure the health status of all test fish, and have a number of sources of specific pathogen free fish for specific protocol use. We are the Office International des Epizooties (OIE) Collaborating Centre for Information on Aquatic Animal Diseases. Our media preparation services are ISO/IEC 17025 standard accredited.
